

**Wings Over the Rockies Captain Jeppesen Foundation Board of Directors
(WOTRCJF)**

50/50 Raffle OFFICIAL RULES

Promoter/Sponsor of Wings Over the Rockies Captain Jeppesen Foundation Board of Directors WOTRCJF 50/50 Raffle (the "Raffle") is the Wings Over the Rockies Captain Jeppesen Foundation ("WOTRCJF") with an address of 7711 East Academy Blvd., Denver, CO 80230. All entrants agree to be bound by the terms and conditions provided in these Official Rules as well as by all interpretations of these Official Rules by the WOTRCJF and by all other decisions of the WOTRCJF including resolution of disputes in connection with this Raffle, which are final and binding in all matters relating to the Raffle. The Raffle is subject to all applicable Colorado laws and regulations.

ELIGIBILITY

The Raffle is open to legal U.S. citizens who are at least 18 years of age or older and present in Colorado at the time of entry. Employees of Wings Over the Rockies, WOTRCJF, their immediate family members, and the Boards of Directors shall not be eligible to enter or win.

ENTRY PERIOD

The Raffle begins on May 1, 2023, at 8:00 AM (Entry Date) and will run until June 30, 2023 at 10:00 PM (Entry Deadline). The Raffle will be subject to an "Entry Period" which starts at 8:00 am on the designated Entry Start date and ends at 10:00 pm on the designated Entry Deadline. The Grand Prize drawing will be held on July 5, 2023, at 10:00 AM. Early Bird drawing one will be held on May 25, at 10:00 AM. All tickets sold between May 1, 2023, at 8:00 AM and May 25, 2023 at 9:00 AM will be entered to win the first Early Bird Prize. The second Early Bird draw will be held on June 15, 2023, at 10:00 AM. All tickets sold between May 1, 2023, at 8:00 AM and June 15, 2023, at 9:00 AM will be entered to win the second Early Bird Prize. The winning number for each Early Bird prize is still eligible to win all other prizes including the Grand Prize. Tickets will be sold for the Raffle throughout the Entry Period, and sales for the Raffle will close on the Entry Deadline, or such other time as determined by the WOTRCJF and with the approval of the Secretary of State.

HOW TO ENTER

To enter the Raffle, entrant must purchase a Raffle ticket. Tickets may be purchased on-line at www.wingscaptainjeppfoundation5050.org or through point of sale devices located at Wings Over the Rockies Air & Space Museum and Exploration of Flight throughout each Entry Period. Raffle tickets will be sold in the following amounts: ten (10) raffle tickets for \$10, one hundred (100) raffle tickets for \$25, and two hundred fifty (250) raffle tickets for \$40. There is no limit on the number of raffle tickets an individual

may purchase. Each entrant is eligible for the Grand Prize drawing, Early Bird drawing one and Early Bird drawing two. All raffle ticket purchases must be completed by the end of the Entry Period to be eligible for the applicable drawing. All raffle ticket purchases are final, and no refunds or replacements will be issued.

WINNER SELECTION

One winner will be selected randomly for the Grand Prize drawing and each of the Early Bird drawings. All draws will take place at the Exploration of Flight, 13005 Wings Way, Englewood, CO 80112. All winning raffle ticket numbers will be announced, and the winning raffle number will also be posted on the WOTRCJF social media pages and at www.wingscaptainjeppfoundation5050.org and will be posted for 30 days. Additionally, purchasers may also contact the WOTRCJF at 720-502-0139 to check the winning number. Winners need not be present to win.

PRIZE CLAIM

There are two (2) ways for a winner to claim a prize: (a) if winner is present at the Exploration of Flight when the winning raffle ticket number is announced, the holder of the winning raffle ticket must bring the winning ticket and valid ID to the WOTRCJF office located at 13005 Wings Way, Englewood, CO 80112, where they will receive additional information on how to claim the prize; or (b) if winner is not present at the WOTRCJF when the winning raffle ticket number is announced, the winner may contact WOTRCJF Raffle Manager Info through the WOTRCJF office within thirty (30) days of the end of the Entry Period, by close of business that day, in order to receive more information on how to claim the prize. In the event: (i) that the winner does not contact the WOTRCJF within thirty (30) days of the end of the Entry Period (ii) that the winner is ruled ineligible for any reason; or (iii) that the winner declines the prize, the prize will be forfeited and will be retained by the WOTRCJF. WOTRCJF has no obligation to contact potential winners. WOTRCJF, its members, or any of its entities are not responsible for lost, interrupted or unavailable network, server or other connections, miscommunications, failed phone or computer hardware or software or telephone transmissions or technical failures, garbled or jumbled transmissions or other errors of any kind, whether human, mechanical or electronic; including without limitation the incorrect or inaccurate capture of winner information online, or for lost, late, incomplete, damaged, destroyed, delayed, stolen or misdirected winner information. Winners will be required to sign a Declaration of Eligibility attesting to the fact that he/she is 18 years of age or older, as well as other terms and conditions as designated by WOTRCJF and consent to the use of his/her likeness to collect the prize.

PRIZE DESCRIPTION

One Grand Prize entrant who purchased a winning raffle ticket will receive one half of the total proceeds, with a minimum guaranteed payout of no less than \$500.

Early Bird Prize One is one hour in a flight simulator at Wings Over the Rockies, valued at \$45.00 and a one-year membership at Wings Over the Rockies, valued at \$100.00

Early Bird Prize Two is an introductory flight in a Tecnam P2008 single-engine airplane, valued at \$150.00 and a one-year membership at Wings Over the Rockies, valued at \$100.00

The proceeds being the value of all monies collected from tickets purchased during the duration of the event. All prizes will be delivered via check within thirty (30) days of the winner delivering the winning raffle ticket, executed Declaration of Eligibility, and all other required documents to the WOTRCJF. For security and safety reasons, no cash payments will be made to the Raffle winner. Unclaimed winnings will be retained by the WOTRCJF which will support and enable aerospace educational opportunities for youth in the spirit of Captain Elrey B. Jeppesen. This will include scholarships awarded to young people to pursue their dreams in aviation. This Raffle is being conducted pursuant to Bingo-Raffles License #2023-18209 issued to the Wings Over the Rockies Captain Jeppesen Foundation Board of Directors by the Colorado Secretary of State's Office, and is being conducted in accordance with the applicable provisions of the Colorado Constitution (Section 2 of Article XVIII), Colorado's Bingo and Raffles Law (Colorado Revised Statutes, Title 21, Article 24, Part 6), and Colorado's Rules Covering and Regulating Bingo/Raffles (8 CCR 1505- 2). The Raffle is subject to these Rules, the laws of the State of Colorado, and Applicable Law. If there is a conflict between these Rules and the laws of the State of Colorado, the laws of the State of Colorado shall govern. WOTRCJF reserves the right to modify the Rules and/or impose additional conditions, procedures, and requirements as may be necessary or required for the Raffle and the award of prizes hereunder to comply with the laws of the State of Colorado and Applicable Law. This Raffle is void where prohibited by law. These rules are copyrighted proprietary materials and may not be copied, reproduced, or used in whole or part in any manner.

TAXES

The prize winner is solely responsible for all applicable federal, state, and local taxes and any expenses associated with the Raffle, unless otherwise indicated.

ODDS OF WINNING

The odds of winning will depend on the number of eligible entries received.

RELEASE OF LIABILITY AND INDEMNIFICATION

By entering the Raffle, each entrant agrees to follow these Raffle Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that entrant may have or that may arise against WOTRCJF and each of their

subsidiaries and related entities, (collectively, the “Released Parties”), with respect to or arising out of either (i) entrant’s participation; or (ii) the receipt or use of the prize awarded in the Raffle. By entering the Raffle, each entrant further agrees to defend, indemnify and hold harmless the Released Parties and their insurers against any and all damages, costs, judgments, and/or expenses (including but not limited to attorneys’ fees and/or other legal fees) they may incur as a result of claims made against them in connection with either (i) entrant’s participation; or (ii) the receipt or use of the prize awarded in the Raffle.

WOTRCJF reserves the right to cancel, modify or suspend the Raffle and/or change dates relating to the promotion in case of schedule changes, acts of God, force majeure events, computer viruses, bugs, corruption or unfairness of the security or administration of the Raffle, or for any other reason at the sole discretion of WOTRCJF and with the approval of the Secretary of State.
